Membership Committee

Golf Tournament

Assist in the organization and execution of the annual Golf Tournament. Aid in the recruitment of teams. ***The Chair and Co-Chair of this Task Force automatically serve on the event sponsorship committee.**

Boos and Baskets

Assist in the organization and execution of annual Boos and Baskets Silent Auction Fundraiser. Help solicit and collect auction items. Assist with event marketing, set-up and breakdown. ***The Chair and Co-Chair of this Task Force automatically serve on the event sponsorship committee.**

Event Sponsorship

Coordinate the acquisition and disbursement of sponsorship funds for the association. ***The Chair and Co-Chair of each event committee and task force are automatically members of this task force.**

Community Service

Assist in the organization and execution of community outreach initiatives, such as the annual box fan and blanket drives. ***The Chair and Co-Chair of this Task Force automatically serve on the event sponsorship committee.**

Works to create and sustain an inclusive culture at the Association that embraces diversity at all levels of the organization. Focuses on promoting and championing equity for home and property owners, as well as industry members.

Circle of Excellence Committee*

Reviews and revises COE rules and regulations for Board of Directors approval. Reviews and recommends applicants for Board of Directors approval. Organizes the award event. ***Only past recipients may serve.**

RPAC/Legislative Committee

Brings legislative issues to the committee for discussion. Educates membership on legislative issues. Participates in candidate screening interviews to contribute and endorse local candidates. Conducts RPAC fundraising campaigns. Attends local government meetings/events. RPAC Contributors will receive priority placement. Screening committee will be organized based on criteria set by CCRA BOD.

Contract Committee

Reviews CCRA standard contracts and forms. Formulates recommendations and updates to the Board of Directors for approval. Affiliate attorneys and lenders may serve this committee.

Plans training and Continuing Education opportunities for the membership. Recommends action to the Board of Directors for approval. Affiliate members may serve this committee. **Priority will be given to LLR licensed instructors.**
